

ABSTRACT

This study examines illocutionary acts in the conversation between Jesse Choi and Maudy Ayunda, aiming to identify the types and functions of illocutionary acts used in Maudy Ayunda's podcast. using Searle's (1979) theory to identify the types of illocutionary acts and Leech's (1983) theory to determine their functions, this research applies a qualitative descriptive method and Spradley's analytical techniques.

The results show four types of illocutionary acts: representatives with 35 instances, expressives with 21 data, directives with 29 data, and commissives with 5 data. About functions, there are three types: collaborative with 59 data, competitive with 19 data, and convivial with 12 data.

The study concludes that representatives are the most dominant type of illocutionary act, as Jesse Choi and Maudy Ayunda frequently state facts and affirmations. The collaborative function is also the most prevalent, as their conversation aims to share experiences in a supportive and cooperative manner. The dominance of representatives and the collaborative due to the close relationship between Jesse Choi and Maudy Ayunda since they are spouse and knowing each other.

Penelitian ini mengkaji tindak ilokusi dalam percakapan antara Jesse Choi dan Maudy Ayunda, dengan tujuan mengidentifikasi jenis-jenis dan fungsi tindak ilokusi yang digunakan dalam podcast Maudy Ayunda. Menggunakan teori Searle (1979) untuk mengidentifikasi jenis tindak ilokusi dan teori Leech (1983) untuk menentukan fungsinya, penelitian ini menerapkan metode deskriptif kualitatif dan teknik analisis dari Spradley.

Hasil penelitian menunjukkan adanya empat jenis tindak ilokusi: representatif 35 data, ekspresif 21 data, direktif 29 data, dan komisif 5 data. Dalam hal fungsi, terdapat tiga jenis: kolaboratif 59 data, kompetitif 19 data, dan convivial 12 data.

Penelitian ini menyimpulkan bahwa jenis tindak ilokusi yang paling dominan adalah representatif, karena Jesse Choi dan Maudy Ayunda sering menyampaikan fakta dan pernyataan. Fungsi kolaboratif juga paling menonjol, karena percakapan mereka bertujuan untuk berbagi pengalaman secara mendukung dan bekerja sama. Dominasi representatif dan fungsi kolaboratif ini disebabkan oleh hubungan dekat antara Jesse Choi dan Maudy Ayunda, mengingat mereka adalah pasangan suami-istri dan saling mengenal dengan baik.
